It's a story of legacy, it's a story of community, and - I think you'll agree it's a story worth sharing.





Rennick and Dee Andreoli Family Fund

Beneath a blanket of August sun and humidity, Rennick and Dee Andreoli uncovered a little piece of heaven – or, at the very least, a haven for a special group of children.

Their afternoon at Akron Rotary Camp began with sounds of water splashing, counselors cheering and little voices laughing: a melody as sweet as the ice cream in the dining hall freezers. But that all changed as they took a few steps inland. There, they saw 50-year-old, concrete-slab cabins with no air conditioning, low ceilings and "everybody living on top of each other." "The conditions were just incomprehensible," Rennick said, especially considering their precious inhabitants: children with disabilities.

"I just couldn't imagine how the counselors and children could live in these conditions," he said. "It immediately touched our heartstrings."

Their heartstrings quickly formed a symphony: "I reached out to Akron Community Foundation," Rennick explained, "and they connected me with other donors whose philanthropic goals were comparable to ours." The result: approximately \$250,000 in contributions to rebuild the camp's cabins – just in time for summer. And, as the operator of two hotels in Fairlawn, Rennick was able to leverage his relationships with local vendors to secure reduced-cost materials and labor, which stretched donors' dollars even further. "I tapped a lot of people on the shoulder, and everybody responded very positively," he said.

When he reflects on the project's progress and the community's overwhelming support of it, Rennick admits he gets choked up: "To be able to see the look on the families' and the children's faces when they come and see these new cabins, I think everybody would shed a tear."

William and Elizabeth Sandwick Fund

While other children were off riding bikes and skinning their knees, Betty Sandwick was admiring high art.

"(My) grandmother was one of the founders of the Pasadena Playhouse," Betty said. "She took me when I was 3 years old to see Lily Pons in 'Madama Butterfly,' which of course was an art, music and theater experience. I guess I've loved it ever since."

And art wasn't just part of her family; her family was part of art. Her great uncle, Samuel Pierpont Langley, was the third secretary of the Smithsonian, and her husband, businessman William Sandwick, attended Yale with artist Claes Oldenburg.

"I taught school while my husband went to (college), and we were starving to death, but art is almost always free, and we were in a position to take advantage of all of that," she said.

Upon relocating to Akron, Betty found a sanctuary in the Akron Art Museum, where she became a docent within three months of moving here. "The wonderful part about being a docent is ... it's an education experience," she said. "There's a lot here to learn, and all the time. That's the beauty of being in a museum: It's a changing experience, and enriching."

When the art museum announced plans for a major expansion, Betty decided to give back to the institution that had given her so much. She opened the William and Elizabeth Sandwick Fund at Akron Community Foundation, both to support the new building's construction and to support the museum forever in her and her husband's name.

"Look how the museum has turned out," she said. "It's very rewarding, like having a garden and seeing it grow."

Hudak Family Fund

EST. 2005

When Barb Hudak's niece Katie was diagnosed with autism, it shattered the confidence of the entire family.

"To show you how really sophisticated we thought we were, we said, 'What is it?' Then we said, 'Just tell us where we go to get it fixed.""

They soon came to a harsh realization: You don't fix autism; you live with it. And while an early diagnosis was integral to Katie's development, treatment options were few and far between. "There was nothing here," Barb said. "Nothing."

They found help for Katie five states away at the Dan Marino Center in Florida. But Barb soon learned that many local families were not so fortunate. "People here would tell me, 'My grandson has autism,' or, 'My next door neighbor's daughter has autism.' And I would ask if they were finding help. And they said, 'We're struggling, we don't know where to go, who to turn to.' I knew then that the community needed something," she said.

In 2005, Barb started the Hudak Family Fund at Akron Community Foundation, which supports research and treatment for autism. Her goal is to improve the lives of local children and families affected by the autism spectrum disorder.

"Early diagnosis, early intervention – it's not the cure, but it is the key," she said. "If families can do that for their children, they will reap the rewards many times over. And when I hear, 'My child now talks,' or, 'My child now plays with other children,' or, 'My child can now look you in the eye,' I know the Hudak Family Fund has provided the right thing."

Barbara D. Mathews Ladybug Fund

As Mark Mathews' mother, Barbara, neared the end of her two-and-ahalf-year battle with cancer, she looked at him and said, "I've got a lot more stuff to do."

"She wasn't accepting of the fact that maybe she had an illness that was going to shorten her life," Mark recalled. Right then and there, he committed himself to carrying on her legacy of helping greater Akron's less fortunate residents.

As a former FirstMerit executive and a retired Akron Public Schools teacher and administrator, Barbara had a long history of helping those who "just needed a break," particularly young people. According to Mark, she became an educator to give disadvantaged children a leg up. "If they got a good education through the public school system, then they would have more opportunities in life," he said.

And it was in the classroom that Barbara became known for her ladybugs. "There was this song," he said. "Whenever it was time to settle the kids ... she'd sit down at the piano and jam out on the Ladybug Song." Today, its lyrics represent much more than a simple melody; they characterize his mother's very nature. "Oh, ladybug, come here and sit upon my shoulder, I will not harm you'... It's just this really catchy tune that ultimately we got sick of, but now we appreciate all the more," Mark said.

In 2009, following his mother's death, Mark and his family started the Barbara D. Mathews Ladybug Fund at Akron Community Foundation, which continues her giving legacy in the community. It's a legacy his son, Myles, has already embraced: For his birthday, Myles asked friends and family not for gifts but for donations to the Ladybug Fund. "I look at him, and I go, 'Where do you get that?" Mark said. Then, with a smile, he remembers: "He's Barbara Mathews' grandson."

Now

Cash gifts, also payable by check or credit card, offer you the greatest and most immediate tax deductibility available under IRS law.

Private foundation conversion can help you avoid burdensome and costly administration while continuing your organization's charitable purpose forever. The community foundation's 501(c)(3) taxexempt status results in greater tax benefits for your donors and no mandatory payouts for you. **Stocks, bonds and mutual funds** can translate to a charitable deduction for the current market value of your asset, even if you bought it for far less, and may help you avoid paying capital gains tax.

Closely held stock gifts offer you a charitable deduction for their appraised fair market value and may help you avoid paying related capital gains tax.

Real estate gifts of home, business or land offer powerful tax benefits, and the foundation's separate LLC can handle your transaction simply and efficiently.

Later

Bequests left via will or trust can help you reduce your estate tax while supporting your community in a permanent, public way.

Charitable gift annuities offer you stable, secure income while giving you an immediate tax deduction for a portion of your gift.

Deferred gift annuities offer younger donors the charitable benefits of an immediate gift annuity while allowing time for retirement earnings to build before they begin taking payments.

Charitable lead trusts may enable you to transfer appreciating assets to family members tax-free while making gifts to Akron Community Foundation in the interim.

Charitable remainder trusts are the most flexible life income vehicle, paying you income for life while offering you an immediate tax deduction for a portion of your gift. You can make additional gifts to the trust as circumstances allow. **Charitable remainder annuity trusts** offer you predictable income and an immediate tax deduction for a portion of your gift. They are invested and managed separately, and you avoid all capital gains tax on any appreciated assets you contribute to them. They also reduce your estate tax liability.

Life insurance allows you to make a significant charitable impact at very little cost to you. By naming the foundation as a beneficiary, you can write your future charitable legacy. By donating an existing policy, you can take an immediate tax deduction equal to the policy's cash value.

Retirement plans, when passed on to an heir, are quickly depleted by double taxation. By naming Akron Community Foundation as the beneficiary of your plan, you can avoid taxes, leave more to your family and preserve your hard-earned assets for the good of your community. If you are age 70½ or older, you may also donate up to \$100,000 of your IRA assets to the foundation without first counting it as income.

Yourself

Donor-Advised Funds allow individuals, families and businesses to develop their own philanthropic story by actively recommending grants during their lifetime. These funds are a great alternative to a private foundation and offer you many of the same benefits with less administration and cost.

Designated Funds can sustain your favorite nonprofit organizations both during your lifetime and beyond. A single fund can support one or more charities, and you can make grants that fund a group's general mission or a specific program. Agency Endowment Funds guarantee nonprofits a steady stream of support for their charitable mission with periodic grants from their fund. Organizations with endowment funds benefit from the foundation's financial stability and integrity, thus assuring donors that their gifts will be managed prudently.

With Help

Scholarship Funds help students from a particular school or field continue writing their educational stories. You can start your scholarship fund with an initial gift of \$25,000, and you can appoint — and even participate in — the committee that selects its recipients.

Field of Interest Funds have a common theme: preserving our donors' philanthropic passions. You can designate one or more causes for your fund to support, and a foundation committee will recommend grants to promising projects in your areas of interest. **Unrestricted Funds** give the foundation a major role in the community's ever-changing storyline. The board and staff identify the community's most compelling needs and award grants from your fund to the programs best suited to meet them, thus making good use of your charitable dollars.

With a designated fund, you can fund one or more of your favorite charities with periodic grants. Are you a nonprofit organization that wants to build a more permanent, predictable stream of income?

In 1929, when the Goodyear-Zeppelin Corporation built an airdock for constructing its blimps, it never could have imagined its impact on nature. Toxic chemicals would contaminate the Adam's Run creek and the soil around it. In 2002, thanks partially to an \$18,000 grant from the Helen S. Robertson Fund, the Western Reserve Land Conservancy bought nearly 9 acres surrounding Adam's Run and worked with Lockheed Martin Corp. to create a lasting greenspace. This year, with grants from the Gertrude F. Orr Trust Advised Fund and the Polsky Fund, it began a project to link the property with that of nearby Haley's Run, thus connecting the Ohio & Erie Canal Towpath to Springfield Lake.



Since 1999, Akron Community Foundation and the City of Akron have teamed up to revitalize local neighborhoods through the Neighborhood Partnership Program. This collaborative grant initiative provides matching grants for community projects that directly benefit local residents, such as playground improvements, vacant lot beautification and block watch programs. This year, a \$2,000 grant made possible the DeBord Community Halloween Party in Kenmore, where local residents gather for a family-friendly costume party complete with music, food, hay rides and appearances by local celebrities.



There's something about the local art and music scene that draws people to downtown Akron. One of the biggest of these draws is the annual "Stop the Violence" Hip-Hop Showcase at Lock 3, which brings together people of all ages and races for an exciting series of live hip-hop performances. The event is family-friendly and emphasizes the positive values of traditional hip-hop culture. It also highlights community services available to local residents, like preventative health care and free media training. Donors to the foundation's unrestricted funds helped make the event possible for a third consecutive year.



Thanks to your contributions and the community foundation's careful cultivation, our collective seed grew more than 7 percent this year. Your charitable branches reached all corners of the community through grants from your donordirected and discretionary funds. But your contributions represent more than mere grants or charitable gifts. What an exciting year it was for Akron Community Foundation and the community as a whole. Despite the lingering effects of 2008's financial decline, we saw glimmers of regrowth among greater Akron's nonprofits, families and businesses. Your community foundation grew 7.45 percent over the previous year, and as of March 31, 2011, it held more than \$135 million in philanthropic capital. The foundation's investments continued to outperform the market average, earning 12.5 percent.

This year, we also celebrated, and were inspired by, your incredible generosity. Your contributions of \$2.66 million helped to award 900 grants and distributions totaling \$6.23 million, which enriched all corners of our community. While discretionary funding remained steady, you stepped up when the community needed you most, increasing your designated and donor-advised grants by 13 percent. This runs counter to the trajectory of many foundations, 50 percent of which either decreased or saw no increase in grant-making last year.

Your increased support was possible thanks to Akron Community Foundation's spending policy, which is based on the previous 12 quarters' assets. This allowed you to fund important programs during a time of great economic turmoil, while the foundation protected your philanthropic dollars during the market's volatility. As a donor, we know you value this approach, and it's a trust we take very seriously.







Kathryn Hunter

41st Bert A. Polsky Humanitarian Award recipient

When Kathryn Hunter read "The Feminine Mystique" in 1963, she was stunned to learn a simple truth: Many women were not only unhappy with their lives as homemakers, but they had no idea how to change their futures.

"It just struck me that it was very important to help women get back into school or the job market," she said. "I thought there should be a course to help them, so I started one."

Hunter's first class at the University of Akron attracted more than 100 people, and she went on to help dozens of women reclaim their passions. As the president of First Akron Corporation, Hunter also used her knowledge of greater Akron to advocate for nonprofits, particularly local arts organizations. She is a



founding trustee of E.J. Thomas Performing Arts Hall and is on the development board of the Akron Symphony Orchestra. She also spent years on the advisory boards of WKSU and the Ohio Ballet, along with those of her alma maters, Ohio Wesleyan University and the University of Akron.

Her long history of volunteering while also growing her own business – and, at one time, running two local newspapers – led Hunter to be honored with a long list of awards during her lifetime. This year, she proudly added the Bert A. Polsky Humanitarian Award to her accolades.
